Dear County Executive Picente,

The Department of Water Quality and Water Pollution Control ("Department") seeks to retain Critical Path Engineering Solutions, PLLC ("CPES") to perform engineering services in connection with certain projects, including the renewal of the Department's State Pollution Discharge Elimination System permit, the performance of a headworks analysis, engineering design in support of valve replacements at the Sauquoit Creek Pumping Station, engineering work in connection with evaluating additional improvements to Department facilities, and technical support with respect to various funding applications.

The Department issued a Request for Proposals (No. 2023-332) and received multiple responses. The Department scored and ranked them. The highest rated proposal was submitted by CPES. CPES has broad experience with respect to engineering and regulatory compliance with wastewater systems. The billing rates submitted with its proposal are reasonable for the nature of the services provided. Based on discussions with CPES, the Department wishes to enter into a master services agreement for one year, with up to two additional one-year terms. The annual fee will be \$40,000, for a maximum fee of \$120,000 (the first year plus up to two renewal terms).

The Board of Acquisition and Contract accepted the CPES proposal on April 19, 2023. I respectfully ask that you consider the attached agreement and forward it to the Oneida County Board of Legislators for consideration and approval. Thank you in advance for your consideration.

Dear County Executive Picente:

In January 2023, the Board of Legislators approved a reallocation of the titles Deputy County Clerk and First Deputy County Clerk. At that time, the previously adopted title Second Deputy County Clerk was not in use. I recently met with County Clerk, Mary Finegan, to assist in addressing ongoing staffing needs in the County Clerk's Office, specifically as they relate to records management. Ms. Finegan has decided that she would like to utilize the previously adopted title Second Deputy County Clerk, as this is a management title focused on oversight of the County's electronic management system. Ms. Finegan's plan is to reclassify an existing vacant position and the necessary form to do so has been submitted to my office, and no additional positions are requested at this time.

In order to keep proper allocation of titles in the County's salary plan, given the reallocations to Deputy County Clerk and First Deputy County Clerk, I am recommending that the title Second Deputy County Clerk be reallocated from Grade 26M, Step 4, \$44,861 to Grade 31M, Step 4, \$53,329.

If you concur with this request, I respectfully request that you forward this to the Board of Legislators for consideration at their May meeting. As always, I am available to address any questions or concerns that either you or the Board may have regarding this matter.

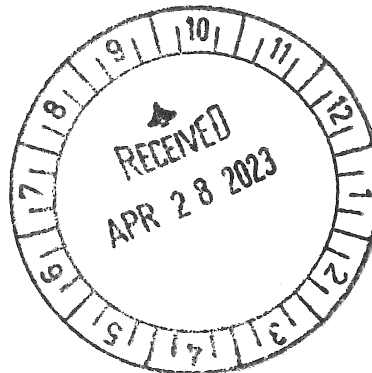

New York State Department of Transportation rules and regulations for Locally Administered Federal Aid Projects apply. Due to the complexity of these rules and regulations, it is very difficult for local municipalities to complete projects within budget and schedule constraints. Oneida County has the experience, expertise, and financial flexibility required to successfully complete Locally Administered Federal Aid Projects.


Therefore, the Department of Public Works proposes providing assistance to the Town of Forestport, Town of Trenton, and Village of Boonville. NYSDOT would designate Oneida County as the Project Sponsor thereby allowing Oneida County to coordinate design, construction inspection, and construction contracts/services. Oneida County would execute state/federal aid agreements, consultant agreements, and construction contracts. In addition, Oneida County would make first-instance payments and secure state and/or federal reimbursement of up to 100% of eligible expenditures. The local municipality would be responsible for 100% of all ineligible and/or non-reimbursable project expenditures thereby insuring zero cost for Oneida County.

If providing the aforementioned assistance is acceptable, please forward a request to the Oneida County Board of Legislators to increase the budget for Capital Project H-557, DPW Bridge New York, as follows.


Dear County Executive Picente,

The Department of Emergency Services seeks to enter into a maintenance/support agreement with TriTech Software Systems with respect to its proprietary software systems for the term January 1, 2023 to October 31, 2023. The agreement will provide access to TriTech's customer call center for product support 24 hours per day, 7 days per week, and provides both on-site and remote diagnostic capabilities. The agreement covers computer aided dispatch (CAD) and records management systems (RMS) for fire and police. While these respective systems were previously supported by two separate contracts with TriTech, the proposed agreement combines support for both systems into one agreement. The Board of Acquisition and Contract has previously determined that these systems are proprietary in nature and that TriTech is the only company capable of keeping them operational and performing any necessary upgrades and repairs. The cost of this agreement will be \$237,112.26, to be funded by County dollars.

If you find this agreement acceptable, I respectfully request that you forward the same to the Board of Legislators for review.



Authorization to Submit CWSRF Application

Dear County Executive Picente:

Oneida County submitted an engineering report for the above reference project to the New York State Environmental Facilities Corporation (NYSEFC) in June 2022. This was accompanied by a Project Listing application for federal infrastructure funding through the Bi-partisan Infrastructure Law (BIL).

The collection system rehabilitation work undertaken to date has notably reduced inflow and infiltration (I/I) in the sanitary sewers within the Sauquoit Creek Basin. However, I/I in the tributary collection system continues to persist and is substantial during severe wet weather events. Additionally, it has been discovered that substantial I/I in the Starch Factory Creek Interceptor Sewer (which serves East Utica along with portions of the Towns of New Hartford and Frankfort) and North Utica Interceptor Sewer (which serves the Towns of Deerfield, Marcy, and Schuyler along with North Utica and Village of Holland Patent) is significant during severe wet weather and negatively impacts WPCP operations. Therefore, a supplementary phase of collection system evaluation and rehabilitation is warranted to further identify and reduce I/I.

Upon review and consideration, NYSEFC determined that this supplemental rehabilitation work qualifies for BIL funding.

Specifically, NYSEFC has determined this project is eligible for a combination of BIL grant, interest-free financing, and subsidized financing. The grant portion is estimated at \$10,538,500 with \$15,440,000 in Hardship and Subsidized financing.

We were advised within the past week by NYSEFC that in order to secure this opportunity, a full funding application will need to be submitted by June 16, 2023. Therefore, I am requesting permission from you and the Board of Legislators to submit a Clean Water State Revolving Fund application to NYSEFC with further authorization for you to sign the various funding application documents.

Note that applying for grants and other funding sources does not obligate the County to undertake the project, nor accept the funding, should it be awarded. However, actively pursuing available funding sources
