A8422 WHICH WOULD PERMIT ONEIDA COUNTY TO AMEND THE TAX LAW, IN RELATION TO AUTHORIZING ONEIDA COUNTY TO IMPOSE ADDITIONAL RATES OF SALES AND COMPENSATING USE TAXES AND PROVIDING FOR ALLOCATION AND DISTRIBUTION OF A PORTION OF NET COLLECTIONS FROM SUCH ADDITIONAL RATES

WHEREAS, the County of Oneida continues to face shortfalls in its annual budgets attributable to the current state of the economy, the funding of state mandated programs and services and the rising costs of providing non-mandated services to the public, and

WHEREAS, the County wishes to protect its credit rating and promote the stability and viability of future annual budgets while continuing to impose spending restrictions, consolidate services and reduce the workforce in areas that the loss of workers will not compromise or endanger the delivery of necessary County services to residents, and, now, therefore, be it hereby

RESOLVED, that the Oneida County Board of Legislators sends a Home Rule Request to our local representatives in the New York State Senate and the New York State Assembly urging the passage of Senate Bill No. S5587 and Assembly Bill No. A8422 permitting Oneida County to impose sales taxes at a rate which is one percent additional to the three percent rate authorized by law for such county for the period beginning September 1, 1992 and ending on November 30, 2011 and at a rate which is three-quarters of one percent or one-half of one percent additional to the three percent rate authorized by law, and which is also additional to the one percent rate authorized above in this clause for the county, for the period beginning December 1, 2008 and ending November 30, 2011, and, be it further

RESOLVED, that the allocation and distribution formula for the additional one per cent tax as set forth in Section 1262-g of the tax law be extended until August 31, 2011.

RESOLVED, that the Oneida County Board of Legislators urges Senators Joseph A. Griffo and David J. Valesky to enact Senate Bill No. S5587 and urges Assemblywoman RoAnn M. DeStito and Assemblymen David R. Townsend and William D. Magee to enact Assembly Bill No. A8422 that would permit Oneida County to impose sales taxes at a rate which is one percent additional to the three percent rate authorized by law for such county for the period beginning September 1,

1992 and ending on November 30, 2011 and at a rate which is three-quarters of one percent or one-half of one percent additional to the three percent rate authorized by law, and which is also additional to the one percent rate authorized above in this clause for the county, for the period beginning December 1, 2008 and ending November 30, 2011, and allowing the allocation and distribution formula for the additional one per cent tax as set forth in Section 1262-g of the tax law to be extended until August 31, 2011 and, be it further

RESOLVED, that the Clerk of the Board of Legislators is hereby authorized and directed to forward a certified copy of this resolution and a Home Rule Request in the appropriate form to Senators Joseph A. Griffo and David J. Valesky and Assemblywoman RoAnn M. DeStito and Assemblymen David R. Townsend and William D. Magee and to the Home Rule Counsel for the New York State Senate and Assembly.
