Dear Mr. Fiorini:

As part of my State of the County message, I spoke of the economy of Oneida County. We need to remain vigilant regarding the protection of our economic assets. Specifically, the Air Force Research Lab, the Defense Finance Accounting Services and Eastern Air Defense Sector are economic resources which are continually under the threat of closure and relocation.

The Department of Defense is looking at closing facilities to reduce costs. In response to this, Oneida County has begun forming alliances with key state and federal officials to take a proactive stance and respond to any base closure process.

Because we must be pro-active in our defense of these regional economic assets, I am requesting the transfer of \$100,000.00 in economic development funding for the Central New York Defense Alliance as part of a broad-based partnership to convince the Pentagon that our local facilities should be enhanced, not reduced.

I am, therefore, requesting the following transfer for the 2015 fiscal year:

Dear County Executive Picente:

On March 29, 2013 the Master Agreement to provide engineering services for compliance with the consent order issued by the New York State Department of Environmental Conservation (NYSDEC) and for resolving permit issues affecting the Oneida County Water Pollution Control Plant between Oneida County and Shumaker Consulting Engineering and Land Surveying, PC was assigned to GHD Consulting Services, Inc. The Master Agreement calls for the submission of work orders with associated pricing for specific tasks that are needed as the project develops.

GHD has submitted for consideration Work Order 33, Amendment 1 which would cover the final design and bidding of certain expansion and upgrades for the Oneida County Water Pollution Control Plant. It would also bring other aspects of the design which are not scheduled to be built for four (4) to five (5) years to a 60% design level.

Under this Work Order, engineering services will be provided to:

- 1) Advance the preliminary WPCP expansion/upgrades design from 30% to 100% biddable documents for the following components:
  - a) Sanitary Pump Station
  - b) Raw Waste Pump Station
  - c) Grit Removal Facilities
  - d) Primary Settling Tanks
  - e) High Rate Disinfection (HRD) and HRD Outfall
  - f) Hydraulic Improvements
  - g) Physical Condition Upgrades at the Raw Waste Pump Station, Grit Building, Thickener Complex, Disinfection Building, Administration Building and Maintenance Garage
  - h) Electrical Infrastructure Upgrades for the Raw Waste Pump Station, Sanitary Pump Station, Grit Removal Facilities, Primary Settling Tanks, High Rate Disinfection Facilities, Disinfection Facilities, Administration Building

2) Advance the preliminary WPCP expansion/upgrades design from 30% to 60% design status for the following components:

a) Process Upgrades to the Blowers and Aeration Basins

b) Process Upgrades to the Final Settling Tanks

c) Physical Condition Upgrades at the Blower Building, Aeration Basins, and Fred Settling Tanks

d) Electrical Infrastructure Upgrades for the Aeration Basins, Blowers, and Final Settli Tanks

The Sheriff's Office is requesting approval of a contact with Corrections Medical Care, Inc. (CMC) for medical care at the Correctional Facility. At the request of the Attorney General's Office, CMC has restructured their agency to be in compliance with New York State's Medical Code. This Agreement includes Business Associate Agreements with CBH Medical, PC and SM Dental, PC.

The Sheriff's Office has previously contracted with CMC for medical services and an Agreement is currently in effect until December 31, 2016. This new Agreement is at the request of the Attorney General's Office to include the Medical PC and Dental PC to be in compliance with New York State's Medical Code. The remainder of the Agreement is for the term April 1, 2015 through December 31, 2016. The scope of the services and cost of the Agreement have not changed. # Contract between Oneida County through its Department of Emergency Services and Central New York Society For The Prevention of Cruelty to Animals

THIS AGREEMENT, by and between Oneida County, a municipality of the State of New York, with its principal offices located at 800 Park Avenue, Utica, NY, 13501, (hereinafter referred to as the "County") through its Emergency Services Department, located at 120 Base Road, Oriskany, NY, 13424, (hereinafter referred to as "Agency"), and Central New York Society for the Prevention of Cruelty to Animals ("Contractor" or "CNYSPCA") with the office located at 5878 East Molloy Road, Dewitt, New York 13211.

WHEREAS, the County and the Agency are in need of a contractor who may provide animal cruelty services and investigations in cases arising in Oneida County; and

WHEREAS, it is the intention of the Agency to retain the CNYSPCA to provide animal cruelty services and investigations on an as-needed bases (hereinafter the "Project"); and

**NOW THEREFORE**, the parties hereto, in consideration of the covenants herein contained do hereby agree as follows:

## **1. TERM**:

The term of this agreement shall be effective April 1, 2015 and remain in effect through December 31, 2019.

#### 2. SCOPE OF SERVICES:

The CNYSPCA shall:

- a. Promptly respond to, investigate violations and enforce provisions of Article 26 of the Agriculture and Markets Law of the State of New York which are reported to the CNYSPCA and which are occurring within the boundaries of Oneida County. Such services will include, as necessary, seizure of, removal and shelter of any animal found to be the subject of a violation of the above referenced law; and
- b. Work in conjunction with local police, the Oneida County District Attorney's Office and the local humane societies in Oneida County as is deemed necessary by the Agency and the CNYSPCA

## 3. FEE & PAYMENT:

a. The compensation for the rendering of the CNYSPCA's services shall be five hundred twenty-nine thousand, seven hundred fifty-six dollars and ninety-four cents (\$529,756.94) for the term of this Agreement. Payments under this Agreement shall be made in 18 quarterly amounts of \$27,881.94 and one final quarterly payment of \$27,882.02.

- b. In addition to this fee, the CNYSPCA shall be reimbursed for mileage at the current federal IRS approved mileage rate. Mileage reimbursed during the term of this Agreement shall not exceed ten thousand dollars (\$10,000.00) annually for a total of \$47,500 total for the term of the contract.
- c. On a quarterly basis, the CNYSPCA shall submit an Oneida County voucher to the Agency, containing the contract number, contract name, and accompanied by a separate statement of services rendered and time record. The CNYSPCA shall also attach to each voucher a completed Oneida County Form 57 Mileage log.
- d. The Agency shall pay for claimed services when required documentation, as defined herein has been approved by the Agency.

## 4. INDEMNIFICATION:

- a. The CNYSPCA agrees that it shall defend, indemnify and hold harmless the Agency and the County from and against all liability, damages, expenses, costs, causes of actions, suits, claims or judgments arising, occurring or resulting from property damage, personal injuries or death to persons arising, occurring or resulting from or out of the work of the CNYSPCA and its agents, servants or employees, and from any loss or damage arising, occurring or resulting from the acts or failure to act or any default or negligence by the CNYSPCA or failure on the part of the CNYSPCA to comply with any of the covenants, terms or conditions of this agreement.
- b. The CNYSPCA agrees to make no claim for damages for delay occasioned by an act or omission of the County and Agency.

#### 5. EXCLUSIVITY:

- a. Both the Agency and the CNYSPCA retain the right to contract with other independent service providers for such services, which are the same or similar to those provided by the CNYSPCA under the terms of this Agreement.
- b. The CNYSPCA retains the right to provide services directly or indirectly through contracts with another agency as long as those services do not cause a conflict of interest or breach of confidentiality to occur.

## 6. CNYSPCA STATUS:

a. It is intended by both the CNYSPCA and the Agency that the CNYSPCA's status be that of an independent Contractor, and that nothing in this Agreement be construed to create an employer/employee relationship between the CNYSPCA and the County. The CNYSPCA shall not be eligible for compensation due to a) illness; b) absence due to normal vacation; c) absence due to attendance at school or special training or a professional convention or meeting.

- b. The CNYSPCA agrees that at no time shall the CNYSPCA indicate or represent that she is an employee of Oneida County or of the Oneida County Emergency Services Department.
- c. The Agency agrees not to withhold from the payments provided for services rendered for any State or Federal income tax, unemployment insurance, worker's compensation, disability insurance or social security insurance (FICA). The CNYSPCA will indemnify, defend and hold the Agency and the County harmless from all loss or liability incurred by the Agency and/or County as a result of the Agency and/or County not making such payments or withholdings.
- d. The CNYSPCA understands, and represents to the County, that such insurance and tax payments are the sole responsibility of the CNYSPCA.
- e. If the Internal Revenue Service or any other governmental agency questions or challenges the CNYSPCA's independent Contractor status it is agreed that both the Agency and the CNYSPCA shall have the right to participate in any conference, discussion, or negotiations with the governmental agency, irrespective of with whom or by whom such discussions or negotiations are initiated.
- f. The Contractor represents and agrees to comply with the requirements of the Civil Rights Acts of 1964 s amended, the Age Discrimination Employment Act of 1973 as amended, Executive Order No. 11246, entitled "Equal Employment Opportunity" as amended, by Executive Order No. 11375 and as supplemented in Department of Labor Relations, 41 CFR Part 60.
- g. The Contractor agrees to comply with Federal and State Laws as supplemented in the Department of Labor regulation and any other regulations of the Federal and State entitles relating to such employment and Civil Rights requirements.

## 7. SUBCONTRACT:

The CNYSPCA may not assign the CNYSPCA's rights or obligations under this Agreement, or subcontract with or employ another to provide the services described above, without the prior written consent of the Agency.

#### 8. BODY ARMOR:

The County shall provide body armor vests to the Contractor to use during the performance of the services provided hereunder. The Contractor shall maintain and care for the vests in accordance with the manufacturer's instructions.

### 9. INSURANCE:

a. The CNYSPCA shall maintain general liability insurance and will provide the Agency with proof of coverage in the amount of \$1,000,000 per incident and \$3,000,000 aggregate throughout the term of this Agreement. The CNYSPCA agrees to have the County and the Agency each named as an "additional insured" on

- the general liability policy and to provide the County with certificates from said insurance company or companies showing the proof of insurance as stated heretofore.
- b. This Agreement shall be void and of no effect unless each party and other person or entity making or performing this Agreement shall secure compensation for the benefit of, and keep insured during the life of this Agreement, the employees engaged thereon, in compliance with the provisions of the New York State Workers' Compensation law. Each party further agrees to comply with the requirements of the New York State Workers' Compensation Board regarding proof of compliance with the New York State Workers' Compensation Law.

## 10. TERMINATION:

- a. This Agreement may be terminated at any time by either party giving to the other at least thirty (30) calendar days prior written notice of termination. However, in the event the CNYSPCA defaults in the performance of any of the CNYSPCA's obligation under this Agreement, the Agency may terminate the Agreement effective upon written notice served at any time upon the CNYSPCA.
- b. Upon notice of termination, the CNYSPCA shall immediately submit to the Agency all required documentation for services rendered up to the date of termination before a final reimbursement for services rendered can occur.
- c. Upon notice of termination, the CNYSPCA shall immediately deliver to the County all records, reports, case files and any other documents which may be in their possession as a result of their services under this Agreement.

#### 11. LICENSES AND PERMITS:

Each party shall obtain at its own expense all licenses or permits required for its services or work under this Agreement, prior to the commencement of services or work.

#### 12. ENTIRE AGREEMENT:

LOCAL LAW INTRODUCTORY "C" OF 2015 AMENDING LOCAL LAW NO. 1 OF 1956 AS PREVIOUSLY AMENDED BY LOCAL LAW NO. 7 OF 1983 REGARDING PAYMENT OF LIABILITY TO WORKERS COMPENSATION PLAN BY PARTICIPANTS WHO DISSOLVE

<u>Legislative Intent:</u> This Board wishes to adopt a Local Law allowing the Board of County Legislators, in its discretion; to enter into a payment plan for amounts owed to the Workers Compensation Plan by participants who undergo legal dissolution and owe money to the Plan.

**BE IT RESOLVED**, by the Board of County Legislators, Oneida County, that Local Law No. 1 of 1956, as previously amended by Local Law No. 7 of 1983, is amended as follows:

Section 3(3) shall state: A participant in the plan may withdraw from the plan only as of the beginning of the next ensuing calendar year by filing on or before the 15<sup>th</sup> day of July of any year, a certified copy of the resolution of its governing body electing to withdraw from the plan, upon condition that participant shall pay, in one lump sum six months after date of withdrawal, its full liability to the plan as determined by an actuarial firm hired by the Board of Legislators. Any participant who has withdrawn or hereafter withdraws from the plan shall also be responsible for administrative costs incurred for payment of claims, until the ongoing claims shall be closed; billing for administrative costs shall be supplied by the Director of Workers Compensation to the withdrawn participants annually, on July 1 of each year. However, in the event that the participant's withdrawal is due to its legal dissolution, or it legally dissolves on or before the date of its withdrawal, the Board of Legislators may enter into an agreement extending the time to pay such liability owed to the plan for a period of time not to exceed twenty years, upon such terms and conditions as the Board of Legislators shall deem to be advisable.

This local law shall take effect immediately upon filing with the Secretary of State.
