#### **Presentation**

<u>Long Range Transportation Plan 2020 – 2040 Update, presented by Dana Crisino</u>

The LRTP is the fundamental and big-picture document for the 20-year vision of transportation in Herkimer and Oneida Counties. The plan is required to be updated every five years with the last plan being updated in December of 2014. The plan is developed with direct and indirect stakeholders as well as members of the public to ensure that the transportation network is resilient, sustainable, fiscally constrained, and that it meets the goals and objectives of the public.

The plan includes a project listing of future projects that may be included on the 5-year Transportation Improvement Plan (TIP) for capital programming.

The current schedule of adoption is to publically release a draft document at the end of October for a 30-day public review period. A public hearing will be held within the 30-day review period. The final draft of the plan will be presented to the TPC and GP&L at their meetings in November and December 2019 for review and approval. The LRTP will be submitted to FHWA prior to the December 31, 2019 deadline.

#### **New Business**

<u>HOCTS Resolution 2019 – 21</u>, on the question of supporting New York State's Targets for Safety Performance Measures for 2020. The performance measures being the following: reduction in the number of fatalities on roadways by 4%, the overall fatality rate reduced by 4%, the number of serious injuries reduced by 2%, the overall serious injury rate reduced by 2%, and the number of non-motorized fatalities and serious injuries reduced by 4%.

# TIP Local Project Identification

Dana stated that project solicitations were sent out to all municipalities starting in December 2018 and ran through to early March 2019, which resulted in around 25 projects being received by HOCTS. The

TIP has funds reserved for local projects in three blocked PINs. The programming of the projects will commence this winter. Highway Safety Improvement Program (HSIP) is the third block of money that has been reserved from the Region 2 allocation that will be utilized for local projects. The TIP is a living document and proposals for projects are always welcome to be submitted.

### **NYSDOT Region 2 Update**

Deb stated that Region 2 was selected as the only rural region to apply for a USDOT BUILD grant by NYSDOT. \$900 million nationwide grant with \$450 million set aside for rural areas. The grant was submitted for North Genesee Street in Utica to replace the two bridges over both the Mohawk River and the Barge Canal. The bridges are in need of replacement but there is no funds available in the program to do that. \$31 million dollar project asking for \$25 million of funding from the BUILD grant. Awards will be announced November 12, 2019 by USDOT. Benefit to cost ratio of over 4. The bridges would be widened to a 3 lane section with a wider 10' sidewalk/multi use trail.

NYS Route 5s Safety Project in Utica is starting to get defined, curbs are being poured currently, and the roundabout will be started in October dependent on weather. The project will be completed at the end of the next construction season.

NYS Route 51 Bridge over CSX has been opened back up and will be completed this fall.

Bridge NY projects, Litchfield Street in Ilion has yet to be let, it was delayed a year, will be let in December. Higginsville Bridge has been let, it made news with unstable soil conditions causing the piers to be compromised and the current bridge having to be removed. The new bridge will not have the style changed. Roberts Road over Little Fly Creek in Town of Remsen has been completed and opened up. Hawkinsville Road over Fly Creek is open. Utica Street over Oriskany Creek will be opened this fall. Horton Road in Forestport is a project that has yet to be let.

A \$3.1 million paving project is underway on NYS Route 49. NYS Route 5s from Little Falls to the Montgomery County line is wrapping up. NYS Route 12 from the Utica city line to Putnam Road will soon commence and it will be a two season job. Harsh winter paving, NYS Route 167 to Otsego county line is a \$1.3 million harsh winter paving project that is finishing up.

A \$3.3 million pedestrian improvement project utilizing repurposed earmark funding from Whitesboro Street to Wurz Avenue in Utica will commence this fall.
